Induction:

This is an Active farm/lease and as such certain rules apply to ensure the safety of yourself and also those that operate the farm/lease.

The priority is to enjoy yourself and be safe so we ask that you abide by the following rules. Any Questions please ask your guide who you have met upon arrival.

RESTRICTED AREAS:

Some areas of the farm/lease are restricted to farm/leasing personnel ONLY. NO prospecting, Detecting, Dirt Gathering or entry to these areas in any way is allowed. Remember this is an active farm/lease.

Other areas as designated by the Mine supervisor on the day. Some areas may be unsafe or unsuitable for use during your stay. These areas will be pointed out and marked.

Site machinery is in various locations and is not to be entered at any time. All site machinery has NO access wherever it is located on the property. This Includes Machinery, Light vehicles, Quads, Motorbikes, Fuel trailers and Pumps.

Entering a restricted area will result in your tour being ended and you being asked to leave immediately.

UNRESTRICTED AREAS:

The main campsite,

Your Guide will be here at night please check in at the end of each day UHF channel 11

YOU MUST leave the area's CLEAN and TIDY

The property is marked and you must adhere to your mapping, as per the restricted area policy.

You may Detect any of those areas within the farm/lease in the designated area

Area's for panning and/or sluicing will be set aside and you will be directed where they are and what activities are permitted. Water is precious so at times Panning and sluicing may not be available.

FLOOD/FIRE EMERGENCY DRILL:

There are 2 entry/exit points to the lease, these are marked.

In case of flood/fire and we need to evacuate the lease, you will be directed down the appropriate track to exit the lease.

You must exit the lease via the recommended track and you may not have time to grab your camping gear and personal belongings. NO Tolerance for evacuation in Flood/Fire scenarios and you must leave the lease immediately.

GENERAL RULES:

Total Fire ban unless otherwise informed in the camping area. The main fire pits are available fires are only permitted within these areas. There is a lot of dry timber in the area so care with fire is needed.

FILL ALL HOLES, 100% of the time, all the time. Please refill every hole you dig. If it can't be filled effectively please inform your guide so we can have it filled. Also cover over any raking that you may have done.

WATER is precious. You will need to supply your own water. At times the flushing toilet may not be available due to water issues.

Alcohol is to be consumed in a manner that is responsible. No Liability will be taken for any injuries or harm that comes as a result of excess alcohol consumption.

Under the provisions of the Trade Practices Act and Various State Laws conditions are implied into contracts that mean that the Provider of Recreational Services, noted below, is required to ensure that the Recreational Services it sells to you are: rendered with due care and skill, are fit for the purpose for which they are commonly bought as it is reasonable to expect in the circumstances or might reasonably be expected to achieve the result you have made known to the Provider. **Name and address of Provider: Golden Prospecting Tours – Thornbill Court, Noosa Heads, 4567**

The Participant acknowledges that the activity being undertaken is an activity being undertaken for the purposes of recreation, education, enjoyment or leisure which involves a significant degree of physical risk. The Provider acknowledges that they are providing Recreational Services detailed below which means; providing facilities for participation in a recreational activity, or training a person to participate in a recreational activity, or supervising, adjudicating, guiding or otherwise assisting a person's participation in an activity. The Participant hereby acknowledges that in attending the recreational activity that there are inherent risks involved to him or her or other people in their care and control. This agreement is directed and limited to inherent risks that are patent. The participants also acknowledges that the purpose of the recreational activity is for the benefit of the Participant and for the benefit of those people attending with the Participant and that at all times the Participant is responsible for his or her own actions and the actions of those other people in his or her care and control. **Description of Recreational Services:** Bush walking on and off tracks, training, wilderness hiking, metal detecting, sluicing, all forms of prospecting for minerals and camping in remote bush areas

The Participant acknowledges that during all times while he or she is attending the recreational activity he or she does so at his or her own risk and that the Participant and other people in the care and control of the Participant will not hold the Provider or any of its employees or agents liable for any personal injury or breach of contract whether caused by the negligence of the Provider its employees or agents howsoever caused or otherwise. The Participant acknowledges that in the event that he or she or any of the other people in their care and control find either or any of them is in difficulty that they are to stop the activity or request that the activity be stopped if appropriate, and seek help and/or assistance and advice. **Declaration and signature** By signing this agreement I understand that the Recreational Services about to be sold to me as set out in this form may cause my and or my dependants personal injury or death. By signing this agreement I understand that I and my dependants waive our rights to sue the Provider for losses relating to my and or my dependants personal injury or death that result from any negligence caused by the Provider.
